The warranty period on coating will not be extended or renewed by repairs and / or other repair work

Guarantee fee

With regard to the products that are provided with a Heras powder coating, an explicit warranty is given if the following occurs:

- · Detachment, scaling, blistering and cracking
- Corrosion with a rust degree greater than Ri3 according to DIN EN ISO4628-3 (ESAP scale)
- · Chalking greater than value 8 for colours and value 6 for white, determined according to ASTM-D659-86 relative to a cleaned surface.
- Heras gives a 10-year guarantee on chalking, discoloration and loss of gloss not exceeding the afore-mentioned tolerances according to the Qualicoat standards.
- · Term of the guarantee: 10 years.
- Reduction of residual gloss below 50% from original gloss, measured according to ISO 2813 standard under an angle of attack of 60 ° (layer thickness at least 60 micrometers for aluminium and 80 micrometers for zinc).

Warranty conditions

A warranty claim can only be made if this warranty statement has been formally issued by Heras BV and signed. Heras BV will make no or limited warranty statement if the products are placed on express request from the client or his authorized representative, but against the advice of Heras.

In the case of powder coating, the warranty only applies if at least 3% of the total painted surface per supplied object or part thereof is defective and visible to the naked eye from a distance of at least 5 meters can be observed.

The right to warranty lapses if:

- the client / guarantee holder has not yet fulfilled his obligations.
- any claims are not reported to Heras BV within one week.
- the products are not updated, repaired, repainted or maintained in accordance with the prescribed method (according to the maintenance conditions for coating).
- · coating systems from suppliers other than Heras have been used without written permission from Heras BV.
- there is complete or partial replacement of parts supplied by Heras BV by parts of one other supplier.
